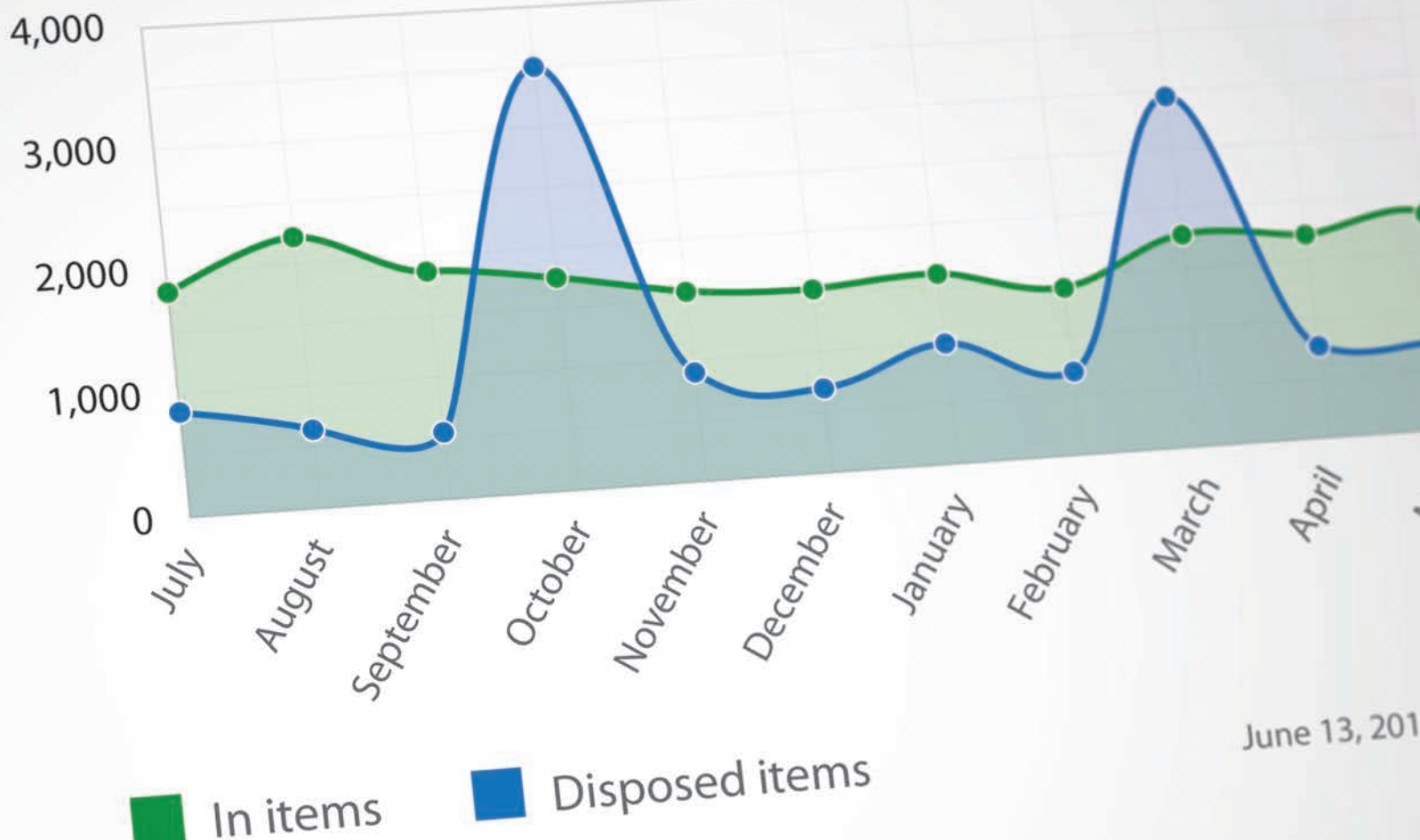
If you're curious about whether your current system is helping you manage your evidence, ask yourself five questions:

TRANSFER

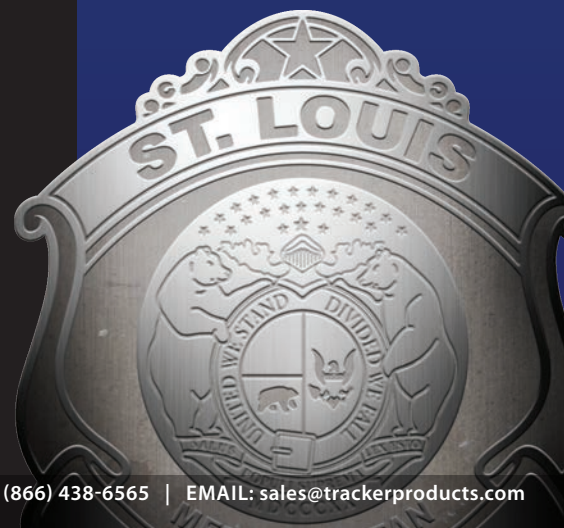
